Things to check prior to moving home

To prepare and plan for a smooth and efficient move to your new home, you:

- Should look for removers displaying the BAR/OFT Approved code logo. These companies are members of the British Association of Removers (BAR) and follow its code of practice which has been approved by the Office of Fair Trading (OFT).
- Should plan your move well in advance. Contact your local BAR member up to one month before you hope to move even if you don't know exactly when the big day will be. They will tell you what they offer and the areas you need to think about. This way you can plan your time and concentrate on the essentials.

- Should consider using professional packers. If you can afford to have your packing done professionally, do so. BAR members use a range of appropriate packing materials and employ fully trained staff who will pack and unpack your things professionally and safely.
- When using professional packers discuss insurance arrangements, or other protection options as no matter how much care is taken with packing and handling, accidents do sometimes happen. Unless insurance or other protection is obtained, BAR members limit their liability if loss or damage occurs to a maximum of £40 an item. All member companies must have insurance which meets BAR standards and it is strongly recommended that you discuss this with them.
- Should avoid moving on Friday. If you can, avoid Fridays as this day is always busy. Some moving companies may even offer a discount if you move in the middle of the week.



Using a BAR member

All BAR members have signed up to a stringent code of practice that protects and promotes consumers' interests beyond the basic requirements of the law.
